 - You should take into account and adjust any outstanding marina fees with the vendor when negotiating the purchase of the craft.
 - The Eildon Boat Club reserves the right to reposition the boat to a similar pen on another marina at its discretion.
- If you are purchasing a craft from a member, you must apply for a marina pen, mooring or dry storage license, and lodge the application with the Manager, together with the appropriate fee and a Certificate of Currency from an insurer/underwriter covering each craft for public liability for at least \$10,000,000.00.
